1970	Optimism restored	Members and Leaders	Solutions to financial exigency were beginning to show results
1970	Changes in membership criteria	Board of Trustees	Dropped actively from criterion for engaged in community health education; reduced full-time experience requirement for those with graduate degrees to one year from three; and to two years from five for baccalaureate level
1970	Relocation of Central Office Operations to San Francisco	Board of Trustees and Select Staff of the Western Regional Branch of APHA	Faced with financial exigency, SOPHE began sharing office space and staff services with the Program of Continuing Education in Public Health, governed by the Deans of four western schools of public health.
1970- 1975	Membership growth	Membership Committee	The changes in membership criteria, member optimism, and aggressive recruitment, led by Edward J. Roccella and G. David Burgess, stimulated growth from 550 in 1970 to nearly double that at 1,129 in 1975
1970- 1974	Chapter Development	Board of Trustees	Recognized the 12th 13th, 14th, and 15th regional chapters, including: Pennsylvania (1971), Hawaii (1971), Illinois (1972), and Texas (1973). Unfortunately, the Missouri Chapter folded in 1974
1970- 1975	Membership in National Health Council	Representatives to the Council	Sustained membership in the National Health Council and influenced it to prepare information for the President's

1972	Recognition of James P. Lovegren as Executive Director	Board of Trustees	Approved increase to full-time employment for an administrative secretary and designated James as part-time Executive Director on a volunteer basis.
1970- 1975	Finances	Finance Committee	Rebounded from a debt of nearly \$4,000 in 1970 to positive balances reaching \$13,585 by October 31, 1975

1974	Health Education Monographs	Board of Trustees	Approved the provision of the International Journal of Health Education to SOHE members and subscribers to the Health Education Monographs
1975	Hildrus A. Poindexter Award	Black Caucus of Health Workers	William A. Darity, a SOPHE past president received this for his accomplishments in public health. He was the first Black American to hold the position of dean of a school of public health
1975	Health Education Monographs appoints new editors	Lawrence Green and Sigrid Deeds, editors	Focused on attaining research to practice articles for publication
1975	Membership reaches 1,129	Larry K. Olsen, Dave Burgess co-chairs of the Membership Committee	Result of opening the membership to those other than graduates of Schools of Public Health. A campaign to increase Fellows followed
1976	First Code of Ethics	Northern California Chapter lead by Task Force Chair, Elizabeth Bernheimer	Guides professional behavior of health educators toward highest standards. One year later, Paul Mico refines the Code and gathers data on values clarification. Code of Ethics was revised in 1983 and again in 1992. American Association of Health Education produced its own Code in 1994
