





# Information Pollution and Political Power

More than 2.4 billion people use social media (about one third of the world's population), with roughly 330 million people using Twitter as of 2019 (Ortiz-Ospina, 2019).



The true extent of the impact that incorrect information has on our decision making is not well known but a study conducted by the National Bureau of Economic Research found that the continuing coverage and rapid spread of information by Twitter bots alone may have contributed to about 3.23% of the vote to be for Donald Trump (Smialek, 2018).





State lawmakers in 13 states have introduced at least 21 bills since December that aim to restrict colleges' efforts to improve diversity, equity, and inclusion, a *Chronicle* analysis has found.

# South Dakota becomes the 6th state to restrict gender-affirming care for minors

Gov. Kristi Noem said the bill seeks to protect minors from “harmful” medical procedures.



## The future is uncertain for trans kids' medical care

- Florida is one of a growing number of states to prohibit gender-affirming care for transgender minors. It is the only state to do so not through legislative action, but through a vote of its medical boards.
- With the encouragement of Florida Gov. Ron DeSantis, the state's Board of Medicine and Board of Osteopathic Medicine both passed rules that will ban gender-affirming care such as puberty blockers and cross-sex hormones, as well as surgical procedures, for new patients under age 18.
- Dozens of leading U.S. medical groups, including the American Academy of Pediatrics, the American Medical Association and the Endocrine Society, endorse gender-affirming care as time-tested, effective, medically necessary, and potentially life-saving.

## Current COVID-19 Related Legislation

Several bills in MS would require state health officer's orders to be approved by the governor.

---

Legislation in Iowa could prohibit health officials from doing contact tracing.

---

Proposed legislation in Wyoming would prohibit the use of CDC & WHO requirements, mandates and recommendations.

Idaho introduced a bill to criminalize the administration of mRNA vaccines

---

Several states have introduced legislation that takes away the power of health officials to set school-based immunizations and gives it to the legislature.

## Montana rep files bill to ban blood donations from people vaccinated against COVID-19



HELENA, Mont. (TND) — A Republican lawmaker in Montana is worried about blood transfusions from people who've been vaccinated against COVID-19, so he filed a bill to end donations from people who got the shot.

State Rep. Greg Kmetz's bill has the short title "[Prohibit donations of certain blood and blood products](#)," and the long and short of it is,


*“A person may not knowingly donate whole blood containing gene-altering proteins, nanoparticles, high-count spike proteins from long COVID-19, or other isolates introduced by mRNA or DNA vaccines, mRNA or DNA chemotherapies, or other novel mRNA or DNA pharmaceutical biotechnologies.*

<b>Levels of engagement</b>	<b>Explanation</b>	<b>Goal of engagement</b>	<b>Example</b>
Primary	Assumes political system functioning normally. Politicians may not agree with public health, but take it seriously.	Winning conventional public policy battles.	Progress in topical areas such as protecting vulnerable people (seniors, vulnerable adults, front-line workers); letter writing campaigns; community organization.
Secondary	Includes reforms (regulatory, legal, judicial) necessary to make politics work better.	Actions to address social changes described above that have made public health ineffective.	Regulation of social media. Campaign finance reform. Electoral reform (e.g., gerrymandering and voter suppression).
Tertiary	Public engagement is necessitated by continuing deterioration of democratic government.	Apply pressure on, or hold accountable, politicians whose behavior drives disease.	Enforcement of gross negligence standards. Class action suits. Labor action.

There has been an outpouring of advocacy since the pandemic.


